CONSTITUTIONS

1. Name and Registered Office

Under the name "Wendy Holdener Fan Club", a club (not an association in the sense of Article 60 ff. of the Swiss Civil Code) is established, with its registered office in Unteriberg, Canton of Schwyz (SZ), Switzerland.

2. Purpose

The purpose of the club is to support the ski racing career of Wendy Holdener, born 12 May 1993, from and in Unteriberg/SZ, and to promote camaraderie among the members of the club.

3. Funding

To pursue its purpose, the fan club charges an annual membership fee. The amount of this fee is determined annually by the club committee. In addition to the membership fee, voluntary donations and sponsorship contributions are also solicited. Invoices for the membership fee are sent out annually at the end of August or beginning of September and are payable by the end of October. These invoices are sent to all addresses listed in the club's membership register – including members, donors, and sponsors who were registered in the previous year.

4. Membership

Any individual who pays the annual membership fee within the set deadline becomes a member of the Wendy Holdener Fan Club for one year. If someone becomes a member during the current season, they remain a member until the end of that season, even if the duration is shorter than one year.

Donors and sponsors who contribute an amount equal to or greater than the annual membership fee are automatically granted membership.

Wendy Holdener's parents, brother, management, and all current members of the fan club committee are exempt from paying the membership fee.

Membership, donations, and sponsorship are open to both individuals and legal entities.

Members of the Wendy Holdener Fan Club benefit from all services and offers provided by the committee. These include invitations to the annual fan club celebration, organisation of trips to ski races and fan club events, discounts or free distribution of fan merchandise, and more.

5. Exclusion

Any member, donor, or sponsor may be excluded from the fan club at any time and without justification by unanimous decision of the fan club committee.

6. Governance

The Wendy Holdener Fan Club is managed by the fan club committee. The leadership consists of the following roles:

President
Secretary
Treasurer
Equipment Manager
Communications/Photography

The committee constitutes itself and appoints successors in the event of resignations. It ensures the continued functioning of the club leadership at all times.

Responsibilities of Committee Members:

- President:** Leads the club and represents it externally. Convenes committee meetings and has the casting vote in case of a tie.
- Secretary:** Handles written correspondence and prepares the minutes of committee meetings. Also responsible for press articles (may delegate this task).
- Treasurer:** Keeps proper records of the club's income and expenditure. Issues membership fee invoices and manages financial obligations in consultation with the committee. Maintains the membership register, which must be kept up to date. Submits the annual financial report to the committee for approval.
- Equipment Manager:** Maintains and ensures the proper condition of all club-owned materials (flags, banners, cowbells, fan items, etc.). Responsible for issuing and collecting club materials, checking inventory, and maintaining an inventory list. Purchases materials and fan articles in coordination with the committee.
- Communications/Photography:** Maintains the club's online presence (Facebook, Instagram, website). Responsible for photographs during trips and events, and for the club's visual representation to the public.

7. Representation

The committee represents the fan club externally and handles day-to-day business. It may appoint assistants who may also represent the club (e.g. media liaisons, etc.).

8. Liability

The Wendy Holdener Fan Club is liable for its obligations only with its own assets. The committee is prohibited from incurring debt or taking out loans. Otherwise, committee members are personally and jointly liable, without limitation, for resulting claims.

9. Amendments to the Constitution

These statutes may be amended at the suggestion of either the membership or the committee. The committee makes the final decision on any amendments. A unanimous vote is required.

10. Dissolution of the Wendy Holdener Fan Club

The club shall be dissolved once Wendy Holdener's ski racing career has ended and the club's purpose has been fulfilled. Any remaining assets must be used in support of skiing, such as aiding the youth section (JO) of the Skiclub Drusberg-Unteriberg or supporting the racing career of a promising young talent..

11. Entry into Force

These statutes were approved by the fan club committee at today's meeting and come into effect as of this date.
